# ***Efforts to Bring Dark & Quiet Skies into COPUOS's Formal Agenda***

STSC 2023 CRP jointly introduced by:

Chile, Spain, South Africa, Slovakia, Bulgaria, Dominican Republic, Peru, IAU, ESO, SKAO

**Two proposals:** - Dedicated Agenda Item on Dark & Quiet Skies.

- Expert Group with participation from science, observatories & industry

**Broad support**, but no consensus → discussions continued

The issue intersected with **security, sovereignty and strategic uses** of large constellations

the satellite industry




# If a path is blocked, we must chart another: The Group of Friends (GoF)


Expert Group was not feasible → concerns over non-government participation

The GoF ensured:

- **Technical work continues**
- **Broad participation** remains possible
- **Continuity** despite diplomatic rotation



Monitoring impacts, Analysing mitigation, Facilitating dialogue (States ↔ Science ↔ Industry), Preparing inputs to STSC/COPUOS



GoF is informal but **feeds its outputs** into COPUOS

# Conclusions
